

The plans for the building site on our doorstep have still not been passed by the Council's Planning Committee.

Despite no building being built, the demolition work means there has been plenty of disruption, with heavy machinery and lorries coming and going, and parking becoming a problem.

The impact on parking is only going to become worse as construction gets started. And when the new estate is opened, there will be many more residents and visitors looking for parking spaces hereabouts.

Overstrand's car park in particular risks becoming an overflow parking area for our new neighbours and their visitors.

Parking survey

That's why it is vital we get everybody to return the Parking Survey, which we recently posted through every door on the estate. To date, only about a third of you have responded.

It's no good leaving it until it's too late, and then complaining. We need to act now.

We must plan now, and to do that we need your input.

Representing your interests

As Chair of the TMO, I along with Caroline attend meetings with Council officers and the other two TMOs at Mercury House on a quarterly basis to discuss TMO matters.

Presently we are dealing with our new management agreements, looking into the details of the roles and responsibilities of both the TMO and the Council and the funding we receive.

I'm also attending two further outside meetings at the Town Hall on a quarterly basis. These are the Participation Panel, which has representatives from across the borough to discuss and help formulate some of the Council policies when they are reviewed.

I have recently been part of a working group looking at the

specifications for a contract for the repairs and our input has been incorporated into the tender documents for a new contract which will be awarded next year.

We will be consulted and advised of progress and also included in vetting the prospective companies.

My second meeting is the Lease-holder Forum which is again borough-wide and I have recently been elected as Vice-Chair. These meetings deal with leaseholder issues and we are consulted on current and upcoming policies affecting leaseholders.

If anyone has any issues they would like put forward for me to discuss at any of these panels please let me know.

The bins

Anti-social noise

Please show consideration for your neighbours - including those above and below you - by **NOT PLAYING LOUD MUSIC** late at night, and restricting your DIY activities to daylight hours.

You may have seen silver gas canisters discarded in the streets and wondered what they are.

Sadly, they are the evidence of drug taking in our area, and we are not alone in having this problem. Across the country, there is growing concern at the number of young people using nitrous oxide, also known as hippy crack, laughing gas and balloons.

The drug became a craze at festivals and concerts, where it could be bought in balloons to inhale for £2 or less, and is becoming more common as a recreational drug. It works by blocking signals to the conscious mind from other parts of the brain, giving users a brief feeling of intense euphoria and relaxation.

Is it legal?

Under the Psychoactive Substances Act 2016, it is illegal to supply nitrous oxide for its psychoactive effect.

Is it dangerous?

Yes. Short-term side effects can include headaches, dizziness and unconsciousness, while long-term, excessive use has been associated with anaemia, incontinence, depleted bone marrow and numbness in fingers and toes. Deaths are rare, but there have been tragedies.

In 2012, A 17-year-old art student from north London, suffered a cardiac arrest, fell into a coma and died after inhaling the gas. In 2015, a 22-year-old University of Brighton student was found dead with about 200 spent canisters in his room.

Parents beware

Parents, if you see your children with things like this, please take action – your children's health and well being could be at stake. And if you see these canisters lying around the estate, please alert us to them and we will ask the Police to check these areas during their patrols.
